

Vail Spa Deposit and Cancellation Policy

Deposit: 10% of the total vacation cost is due at the time of booking and is non-refundable. Final payment: Final payment is due 14 days prior to arrival for summer bookings (April 16-November 14), 30 days prior to arrival for winter bookings (November

15-April 15), and by November 1st for all holiday bookings (December 19-January 2). For all other bookings, final payment is due 30 days prior to arrival. Final payments are non refundable.

*Please note, even if paying by ACH, wire transfer, or check, a credit card must be on file to guarantee your reservation.
